





Cookies policy

For a correct understanding of the Cookies Policy, whenever we use the word USER we are referring to people who, in some way, use or have an interest in our services and those who interact with our website (browsing, contact and news).

What are cookies and why do we use them?

Cookies are small files saved on the USER's devices, such as computer, smartphone and tablet, when a website is accessed. The use of cookies by MONTREAL is necessary to provide the USER of our website with a good and secure experience.

Types of Cookies

Cookies in terms of their owners can be:

- Proprietary cookies (MONTREAL site): these are cookies created and managed by MONTREAL itself or by third parties on behalf of MONTREAL.
- Third-party cookies: these are cookies belonging to third parties and considered reliable. They are
 added to the USER's devices by third parties, such as analytics systems. Their purpose is to collect
 information on how the USER uses the website, such as the pages visited and the links clicked.
 None of this information can be used to identify you. Its sole purpose is to enable analysis and
 improve the functions of the site.

Cookies in terms of how long they last can be:

- Temporary cookies: these are session cookies. As the name implies, they are temporary and expire when the USER closes the browser, ending the session. Their purpose is to allow language and security control during the session.
- Persistent or permanent cookies: these are cookies that remain on the USER's device until they
 expire or are manually deleted. Their purpose is to store information about the USER, such as
 awareness of the use of cookies on this website.

Cookies in terms of their purpose can be:

- Essential or necessary cookies: These cookies enable essential functionalities such as security, identity verification and network management. These cookies cannot be disabled on our systems.
- Performance/analytical cookies: Aimed at improving the performance of the website by collecting anonymized data on navigation and use of the resources made available. If you do not allow these cookies to be collected, this data will not be used to improve the website.



 Advertising or marketing cookies (third parties): The website depends on the services offered by third parties to improve government information campaigns, offer interactive content, improve usability and facilitate the sharing of content on social networks.
